India's Tea Exports

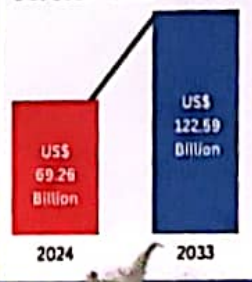
